Specifically, the IRB will: ensure all human subject research conducted at the College is administered in accordance with federal regulations and the College's established human subject research [procedures and guidelines](#); review and approve all proposals for research involving human subjects supported by, conducted at, or associated with the College; confirm that the required elements of informed consent are included in research proposals; conduct continuing review of all approved research at least once annually; and maintain a master list of all open research projects.
