DELGADO COMMUNITY COLLEGE (DELGADO)

The Department of Business Administration of Our Lady of Holy Cross College (OLHCC) and the Business and Technology Division of Delgado Community College (Delgado) have signed an agreement that establishes a 2+2 program. This 2+2 program allows students who complete the courses prescribed in Delgado's Business Administration Associate Degree to transfer to OLHCC and will lead to a Bachelor of Science Degree from Our Lady of Holy Cross College.

2 + 2 Agreement

Program

Delgado Community College (Delgado) students with an associate degree in Business Administration will be admitted as juniors in the Business Administration Department of Our Lady of Holy Cross College (OLHCC), provided they meet OLHCC's admission requirements. Course requirements for Delgado's associate degree in Business Administration are described on page two of this document.

The total number of credit hours required to complete a bachelor's degree in business administration from OLHCC is 127 semester hours and students can transfer up to 63 semester hours for degree credit from Delgado to OLHCC. This is a 2+2 program in which Delgado students will earn a bachelor's degree from OLHCC after successfully completing at least 64 additional semester hours in the Business Program at OLHCC and meeting all OLHCC degree requirements.

Delgado students will follow the requirements in the OLHCC Undergraduate Catalog in force at the time they entered Delgado provided the Catalog is not over 10 years old. In addition, there shall be no break in student enrollment over 5 years.

In order to graduate from OLHCC, students must complete at least 50% of business courses at OLHCC and achieve a quality point ratio of 3.0 or better in all work attempted, all work taken at OLHCC, "C" in all business courses, and 3.0 or better in all course work.

1. Students not completing the degree program at Delgado, regardless of the grades achieved in English or mathematics, must validate that credit for the classes by passing the English and Math Proficiency Examinations. The exam(s) must be passed prior to registration for classes at OLHCC so that the student can be properly placed.
2. Sciences – OLHCC’s General Degree Requirements include 9 hours of science, including 4 hours of biology lecture and lab and 5 hours of another natural science. If the student completes the associate degree program for business at Delgado, the lab requirement will be waived. If the program is not completed, all requirements for science at OLHCC revert back to the original requirement.



Program Renewal


This agreement will be renewed every three years from the date of signing and will be continued, modified, or terminated upon mutual agreement of the parties.






