V. New Business

a) Business & Technology/BUAD

Program Revision: Associate of Science in Business Administration. Revise the Associate of Science in Business Administration: Delete: MATH-118: Algebra for College Students and MATH-128: Explorations in College Algebra from General Education Requirements. Add: MATH-128: Explorations in College Algebra OR MATH-130: Pre-Calculus Algebra AND MATH-151: Finite Mathematics OR MATH-203: Statistics to General Education Requirements. Reduce Approved Electives from a selection of nine (9) credit hours to a selection of six (6) credit hours; Delete: MATH-203: Statistics from Approved Electives; Add: Approved Social Science Course – limit 3 credits to Approved Electives. Total Program Hours decrease from 63 to 60. Program modifications comply with The Board of Regents for Louisiana Higher Education Academic Affairs Policy 2.15. Motion to accept proposal [Motion: Lester Adelsberg; Second: Joan Hodge; Carried, Unanimously]

b) Allied Health/WELL

New Course: WELL-107: Fundamentals of Endurance Training (0-2-1/30). Creation of a new course, WELL-107: Fundamentals of Endurance Training. Course description: "Introduces the fundamentals of proper running and walking. Information will be provided on training methods to help students reach their goal of running/walking an organized race." The course has been offered as a special topics course to determine interest/need, and will incur no additional cost to the College in terms of personnel and/or equipment. e) Agenda Items Removed from Consideration by Division Dean Allied Health/EMTE

Course Deletion: EMTE-100: EMT Basic. Delete the course, EMTE-100: EMT Basic, as the course no longer meets standards dictated by the National Registry of Emergency Medical Technicians and the Louisiana Bureau of Emergency Medical Services.

d) Allied Health/EMTE

New Course: EMTE-110: Emergency Medical Technician (6-0-6 / 90). Creation of a new course, EMTE-110: Emergency Medical Technician. Course Description: "Training in initiating immediate lifesaving measures to patients across the pre-hospital spectrum. It will provide basic knowledge and skills needed in critical situations utilizing minimal equipment." The course content meets guidelines mandated by the National Registry of Emergency Medical Technicians and the Louisiana Bureau of Emergency Medical Services. The course will be taken concurrently with EMTE 120: Emergency Medical Technician Laboratory.

e)—Allied Health/EMTE

New Course: EMTE-120: Emergency Medical Technician Laboratory (0-5-2/75). Creation of a new course, EMTE-120: Emergency Medical Technician Laboratory. Course Description: "training in initiating immediate lifesaving measures to patients across the pre-hospital spectrum. It will provide basic knowledge and skills needed in critical situations utilizing minimal equipment." The course is laboratory based and is offered concurrently with EMTE-110: Emergency Medical Technician. Course content meets guidelines mandated by the National Registry of Emergency Medical Technicians and the Louisiana Bureau of Emergency Medical Services.

f)—Allied Health/EMTE/HESC

Course Deletion: HESC-137: First Responder. Deletion of the course, HESC-137: First Responder, as the course no longer meets standards dictated by the National Registry of Emergency Medical Technicians and the Louisiana Bureau of Emergency Medical Services.

g) Allied Health/EMTE

New Course: EMTE-101: Emergency Medical Responder (3-2-4 / 75). Creation of a new course, EMTE-101: Emergency Medical Responder. Course Description: "Emergency Medical Responder (EMR) provides training in initiating immediate lifesaving measures to patients across the pre-hospital spectrum. The course is designed to prepare students to become certified as an Emergency Medical Responder (EMR)." This course replaces HESC-137: First Responder.

h) Allied Health/EMTE/HESC

New Course: HESC 102: First Aid (3 0 3 / 45). Creation of a new course, HESC-102: First Aid. Course Description: "First Aid training in recognizing life threatening medical emergencies and trauma injuries and the ability to keep the patient in the best possible condition until medical help arrives." The course provides instruction in basic first aid, and is offered to all students.

Technical Division/COSM

Course Revision: COSM-124: Hairstyling (3-7-4 / 150). Revise COSM-101: Hairstyling to reflect contemporary industry standards and practices. Course Description: "Facial shapes, profiles, and body structures are analyzed in order to suggest the most becoming hairstyles for clients. Identification, discussion, and student demonstration of various thermal services are also covered." After discussion, the agenda item was amended as follows: Use higher number — COSM-124 selected after review.

Course Revision: COSM-125: Chemical Services (3-7-4 / 150). Revise COSM-102: Chemical Services to reflect contemporary industry standards and practices. Course Description: "Covers the history and trends of permanent waving and chemical hair relaxing methods as well as the

methods, procedures, and skills required." After discussion, the agenda item was amended as follows: Use higher number — COSM-125 selected after review.

Course Revision: COSM-111: Introduction to Cosmetology (3-4-4 / 105). Revise COSM-111: Decontamination/Infection Control to reflect contemporary industry standards and practices. Course Description: "History, ethics, grooming, safety, and first aid. The LA State Board of Cosmetology Rules and Regulations are discussed. Types and methods of decontamination and sanitation are explained and demonstrated." After discussion, the agenda item was amended as follows: "Change the title of COSM-111: Decontamination/Infection Control to COSM-111: Introduction to Cosmetology"

Course Revision: COSM-112: Properties: Skin, Scalp, and Hair (1-5-2 / 90). Revise COSM-112: Properties: Skin, Scalp, and Hair to reflect contemporary industry standards and practices. Course Description: "Skin and scalp are analyzed according to structure and function. The diseases of the skin, scalp, and hair are also explored."

Technical Division/COSM

Course Revision: COSM-113: Shampooing, Rinsing, and Conditioning (2-5-3 / 105). Revise COSM-113: Shampooing, Rinsing, and Conditioning to reflect contemporary industry standards and practices. Course Description: "Discussion and demonstration of shampooing, rinsing, and conditioning using appropriate solutions and techniques for each procedure to meet the individual needs of the client."

Technical Division/COSM

Course Revision: COSM-121: Cosmetology Anatomy and Physiology (1-3-2 / 60). Revise COSM-121: Cosmetology Anatomy and Physiology to reflect contemporary industry standards and practices. Course Description: "Basic functions of organs and body systems related to specific cosmetology skills are discussed in this course."

Technical Division/COSM

Course Revision: COSM-122: Manicuring and Pedicuring (1-8-3 / 135). Revise COSM-122: Manicuring and Pedicuring to reflect contemporary industry standards and practices. Course Description: "Identification of composition and structure of the nails, as well as characteristics of nail disorders/ diseases are explained. Manicure and pedicure procedures are discussed and performed using appropriate safety precautions."

Technical Division/COSM

Course Revision: COSM-131: Haircutting (2-7-4 / 135). Revise COSM-131: Haircutting to reflect contemporary industry standards and practices. Course Description: "Equipment and procedures for hair shaping techniques are covered. Facial shapes, profiles, and body structure are analyzed to meet client's needs and desires for an attractive cut."

Course Revision: COSM-143: Hair Coloring (1-4-5 / 75). Revise COSM-143: Hair Coloring to reflect contemporary industry standards and practices. Course Description: "Fundamentals of temporary, semi-permanent, and permanent hair color and the methods, skills, and procedures required for each."

Course Revision: COSM-251: Facial Services, Massage, and Make-up (2-3-3 / 75). Revise COSM-251: Facial Services, Massage, and Make-up to reflect contemporary industry standards and practices. Course Description: "Skin types are discussed in order to recommend and perform appropriate facial treatments and massage movements. Factors affecting the choice and application of cosmetic make-up are also explored."

Course Revision: COSM-252: Artistry of Artificial Hair (1-2-2 / 45). Revise COSM-252: Artistry of Artificial Hair to reflect contemporary industry standards and practices. Course Description: "Overview of the types, uses, and special care techniques of wigs and hair accessories."

Course Revision: COSM-254: Salon Management (3-3-4 / 90). Revise COSM-254: Salon Management to reflect contemporary industry standards and practices. Course Description: "Students plan, operate, and manage the school-based salon according to the LA State Board of Cosmetology rules and regulations under instructor supervision."
