

MEMORANDUM OF UNDERSTANDING



BETWEEN

Northwestern State University AND

Delgado Community College

Northwestern State University of Louisiana (NSU) and Delgado Community College (DCC) have agreed to enter into a Memorandum of Understanding for a 2 + 2 program between the two institutions. The 2 + 2 program will allow students to complete the first two years of study at DCC and transfer all credit hours as designated in Appendix A to NSU for completion of the Bachelor of Science in Radiologic Sciences (BSRS). Students transferring to NSU may complete the last two years of their course work at NSU. Both institutions serve constituency needs and are responsive, student oriented institutions that prepare the students to become productive members of society as well as promote the academic development and improvement in the quality of life of citizens in their regions.

This partnership is mutually beneficial to both institutions for several reasons. Traditional and non-traditional students attending DCC will have the opportunity after completing core requirements at DCC to transfer to an RT to BSRS program that will accept DCC credits. NSU will have the opportunity to accept students into the RT to BSRS who are well prepared with foundation course work.

Both the University and the College are accredited by the Southern Association of Colleges and Schools.

Both the University and the College have full-time faculty with advanced academic and professional credentials and both have support resources (i.e., library, on-line access, service courses, and adequate administrative-faculty-staff backup).

In accordance with this Memorandum of Understanding, Delgado Community College agrees to:

Provide academic advising to students who plan to transfer to NSU according to agreements in Appendix A.

Have DCC students who intend to transfer to NSU sign the Intent to transfer form and mail the completed form to NSU. (Appendix B)

Provide students the opportunity to obtain the DCC credit hours as listed in Appendix A of the Memorandum of Understanding between NSU and DCC.

Provide transferring students assistance in completing a NSU RT to BSRS Application for Admission into the RT to BSRS program.

Provide information about the 2 + 2 Agreement in the Delgado Community College General Catalog.

Jointly market the 2 + 2 agreement with NSU.

In accordance with this Memorandum of Understanding, Northwestern State University agrees to:

Provide consultation to DCC regarding required content for the two introductory social work courses.

Receive and maintain "Intent to Transfer" forms from DCC students and honor the agreement regarding academic catalog in effect on the date of the student's signature and the NSU confirmation signature. (Appendix B).

Accept Delgado Community College credit hours as listed in Appendix A of the Memorandum of Understanding between Northwestern State University and DCC.

Provide DCC with copies of the Application for Admission into the RT to BSRS program and other advising materials.

Provide information about the 2 + 2 Agreement in the Northwestern State University catalog.

Jointly market the 2 + 2 agreement with DCC.

By signature of President Randall J. Webb, Northwestern State University and signature of Interim Chancellor Deborah Lea, Delgado Community College, this 2 + 2 Memorandum of Understanding is entered into on the 7th of March, 2012.

This agreement may be revised only with the signatures of the leaders of both institutions.
