

2 + 2 AGREEMENT

between

and

**THE BUSINESS AND TECHNOLOGY DIVISION
OF DELGADO COMMUNITY COLLEGE**



The Business Department of Waldorf College and the Business and Technology Division of Delgado Community College have signed an agreement that establishes a 2 + 2 program. This 2 + 2 program allows students who complete the courses prescribed in Delgado's Business Administration associate degree to transfer and leads to an online bachelor of science degree from Waldorf College.

Delgado 2 Waldorf Agreement

Program

Delgado Community College (Delgado) students with an associate degree in Business Administration will be admitted as juniors in the online Business Administration bachelor of science program at Waldorf College (Waldorf) provided they meet Waldorf's admission requirements. Course requirements for Delgado's associate degree in Business Administration are described on page two of this document.

The total number of credit hours required to complete a bachelor degree from Waldorf is 120 semester hours, and students can transfer up to 60 semester hours for degree credit from Delgado to Waldorf. This is a 2 + 2 program in which Delgado students will earn a bachelor degree from Waldorf after successfully completing 60 additional semester hours and meeting all Waldorf degree requirements as outlined in the grid below.

Only courses for which students have received a grade of C or better will be considered for transfer. Courses were evaluated using the 2013-14 Waldorf College Online Degree Program Catalog and the 2012-13 Delgado Community College Official College Catalog.

Under this agreement, Delgado students, alumni, faculty, staff members, and their spouses and children, who enter Waldorf's On-Campus programs will have the standard application fee waived and receive a \$500 scholarship toward the first year's tuition. Students entering Waldorf's On-Campus programs with fewer than 50 semester hours of credit will be required to reside on campus.

Waldorf College Online Degree Programs

Waldorf's Online Degree Programs are delivered in an 8 (eight)-week format. Delgado students, faculty, staff members, and their spouses and children, who enroll in the Waldorf Online Degree Program will receive a 10 (ten) percent tuition discount and waiver of the application fee. These discounts are offered through Waldorf's Tuition Discount Program. In addition, textbooks are provided at no cost under Waldorf's book grant program.

Under this agreement, transfer applicants must submit the following:

- Application for admission form
- An official high school transcript
- Official transcript(s) from all colleges and universities attended

Transfer credit course waiver

Waldorf generally transcribes credit for transfer courses at the same level at which the credit was earned. If credit from another college was earned at a lower-division level and is determined by Waldorf College to cover material that is largely equivalent to an upper-division course, the college may elect to accept the course and credit as a transfer waiver credit. Transfer waiver courses will be transcribed as a transfer with the original course number and level and number of credit hour(s). The student will receive a course waiver for the upper-division course at Waldorf College. Transfer waiver courses do not count toward the minimum number of upper-division credit hours and the student will be required to take additional upper-division credits in order to satisfy this degree requirement.

In this hypothetical example, a Business Administration major with a course called ABC 123 Business Course for 4 credits on his or her transcript would get a waiver of the requirement for ABC 3000 Business Course at Waldorf. If course content is comparable, the student would receive 4 credits (even though Waldorf lists it as a 3-credit course). The transfer credit could be used to meet a requirement for the major, but it would count as lower-division credit and not toward the minimum number of upper-division credits needed to graduate. The reverse would also be true. A course called ABC 300 Example Course for 3 credits on a transcript would replace ABC 2000 Example Course at Waldorf for 3 credits with a notation on the transcript that the course counts as upper-division. (Note: Courses numbered 100-299/1000-2999 are lower-division, or freshman/sophomore level, and courses numbered 300/3000 or higher are upper-division, or junior/senior level.) Courses accepted as transfer waiver courses are indicated in the attached transfer grid with a (TW) marking.

Program evaluation

Waldorf will evaluate on a regular basis the performance of 2 + 2 students and other transfer students in upper-level business courses and compare their performance to that of continuing Waldorf students. If the performance of 2 + 2 students is significantly lower than that of continuing Waldorf students, faculty representatives from Waldorf and Delgado will meet to enhance the alignment of courses from the two programs.

Accreditation and affiliations

Delgado represents and warrants that it is regionally accredited by the Commission on Colleges of the Southern Association of Colleges and Schools, 1866 Southern Lane, Decatur, GA 30033, since 1971.

Waldorf represents and warrants that it is regionally accredited through the Higher Learning Commission of the North Central Association of Colleges and Schools, 230 S. LaSalle St., Suite 7-500, Chicago IL 60604, since 1948. Waldorf is a member of the Servicemembers Opportunity College (SOC Consortium).

If either party listed within this agreement experiences a change in its accreditation, the party experiencing the accreditation change will provide written notification of said change to the other party within 90 (ninety) days. Written notification of the accreditation change will be dispatched to the current president of the receiving institution.

Program renewal


This agreement will be renewed every three years from the date of signing and will be continued, modified or terminated upon mutual agreement of the parties.

Miscellaneous information

Delgado and Waldorf agree to promote the 2 + 2 agreement, providing timely and accurate information regarding this program. Waldorf will work with Delgado in the distribution of information pertaining to the degree programs and transfer criteria, and make information accessible by way of printed materials and electronic medium.

This agreement may be executed by facsimile. Said facsimile shall be deemed an original document.




