



## **ARTICULATION AGREEMENT**

DCC Programs: Associate of Arts – Louisiana Transfer Degrees with concentrations in Business, Criminal Justice, Humanities, and Social Science and Associate of Sciences – Louisiana Transfer Degrees with concentrations in Physical Sciences and Biological Sciences

SoPA Programs: Applied Computing, Exercise Science, General Legal Studies, Digital Design, Public Relations, Health & Wellness, Homeland Security Studies, Humanities, Social Sciences

This Articulation Agreement between Delgado Community College (DCC) and Tulane School of Professional Advancement (SoPA) is intended to facilitate credit transfer and a smooth transition for graduates of DCC who received Associate of Arts – Louisiana Transfer (AALT) and Associate of Science – Louisiana Transfer (ASLT) degrees in abovementioned concentrations into the Bachelor of Arts (BA) and Bachelor of Science (BS) in the abovementioned SoPA programs. Only students completing one of the aforementioned degree programs at Delgado Community College are assured of transferring 60 credits, and the transfer applies only to degrees offered by the School of Professional Advancement. Students who complete a DCC degree not specified in this document will have their courses individually evaluated for transferability.

The two institutions mutually agree on the following:

- 1. This agreement applies only to students who have met the graduation requirements of DCC and have met all admission requirements to SoPA.
- 2. The Bachelor's degrees herein referenced and administered by SoPA require a minimum of 120 credit hours, of which a maximum of 60 hours can be accepted in transfer from DCC.
- 3. Students may be required to take more than 60 credits to complete their SoPA degrees.
- 4. Courses will transfer as described in the Plans of Study attached.
- 5. The signing institutions shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- 6. Additional requirements and regulations for all degrees appear in the current catalogs for both institutions.
- 7. This Articulation Agreement is effective on the date signed and shall remain in effect for five years from the date of signing, unless terminated or amended by either party with 90 days prior written notice. This agreement will be reviewed by SoPA and DCC after three years to ensure articulation of programs is current. Any changes to the academic programs that are part of this agreement will require a review of this articulation agreement. Reviews will be documented in writing to both parties. This agreement may be terminated by either party for any reason, with or without cause, following provision of 90 days prior written notice.
- 8. Notices. Any notice given pursuant or in respect of this agreement shall be in writing and shall be deemed received (i) on the date such notice is hand-delivered to an authorized representative of the party receiving such notice, (ii) on the first business day following the date on which such notice

is sent prepaid for next-day delivery by nationally-recognized overnight delivery service, or (iii) on the third business day following the date on which such notice is sent by prepaid registered or certified U.S. mail, return receipt requested.
