ARTICULATION AGREEMENT

SOUTHERN UNIVERSITY AT NEW ORLEANS And DELGADO COMMUNITY COLLEGE

Since it is incumbent upon the institutions of higher learning in the State of Louisiana to serve their clients in an efficient manner, and

Since higher education budgets are limited and imaginative methods must be found to maximize state funding without affecting quality, and,

Since Southern University at New Orleans (SUNO) and Delgado Community College (DCC) have service as their major mission to the State of Louisiana, and,

Since cooperation between Southern University at New Orleans and Delgado Community College will underscore for the State of Louisiana the importance of interactions between community colleges and universities, therefore:

Southern University at New Orleans and Delgado Community College do hereby enter into this general articulation agreement.

Southern University at New Orleans and Delgado Community College do hereby agree as follows:

- 1. Review all academic programs at both institutions with a view toward the articulation of numerous programs leading to associate degrees at DCC and baccalaureate degrees at SUNO.
- 2. SUNO will guarantee placement at the junior level, as well as, college credit for all students transferring to accepted programs.
- 3. SUNO and DCC will form a committee whose primary goal will be to promote new cooperative academic programs.
- 4. Each campus will highlight the SUNO-DCC Articulation Agreement in their respective catalogs.
- 5. Each campus will make provisions for recruitment at the partner institution.
- 6. Each campus will communicate announcements of certain major events to the partner institution, such as research, grants, and professional opportunities.

- 7. Selected faculty of both institutions will hold joint meetings at least once a year.
- 8. The appropriate student organizations of both campuses will be encouraged to hold joint meetings at least once a year.
- 9. The two campus newspapers will be encouraged to publish a joint issue at least once a year.
- 10. This articulation agreement is extended to include a Reverse Transfer process whereby former Delgado students enrolled at SUNO transfer credits back to Delgado for the purpose of attaining a degree, diploma, or certification at Delgado. SUNO will forward Delgado a list of students who have earned a minimum of 66 combined hours from SUNO and Delgado with at least 18 or more of the earned hours at Delgado, along with transcripts. Delgado will then evaluate this coursework to determine if degree, diploma, or certificate requirements are met. Once verified the student is notified regarding his or her eligibility, and upon acceptance the student is awarded the associate degree. There is no charge to the student; however, the student is responsible for considering the impact of the awarded degree on his or her federal financial aid eligibility status.
- 11. Each campus will strive to find other areas of cooperation that will strengthen the ties of the two institutions so that they might better serve the State of Louisiana.
- 12. This document shall be reviewed every three years.
